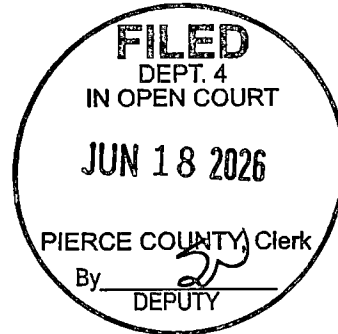

5 entitled Court; and the Plaintiff, Daniel Morris, and members of the class certified in this matter
6 acting by and through class counsel, Micah R. LeBank, Marta L. O'Brien, Colin G. Prince, and
7 John B. McEntire, IV of Connelly Law Offices, PLLC, and the Defendant, State of Washington,
8 acting by and through Nicholas W. Brown, Attorney General, and John R. Nicholson, Special
9 Assistant Attorney General; and these parties having made a stipulation pursuant to
10 RCW 4.92.150, without any admissions of liability, settling and compromising this class action
11 against Defendant, State of Washington, and it appearing to the Court, after a review of the files
12 and records herein that the sum of Eleven Million Five Hundred Thousand and no/100 Dollars
13 (\$11,500,000.00), is a proper and just settlement to be paid by the Defendant, State of
14 Washington, to the Plaintiff, Daniel Morris, and the other members of the class certified in this
15 matter, and the Court being fully advised, now, therefore,

16 IT IS HEREBY ORDERED That the Plaintiff, Daniel Morris, and the other members of
17 the class certified in this matter shall have judgment against the Defendant, State of Washington,
18 for the sum of Eleven Million Five Hundred Thousand and no/100 Dollars (\$11,500,000.00).
19 Additionally, any liens, subrogated interests, or outstanding medical bills of which Plaintiff's
20 counsel has actual or constructive notice shall be resolved out of these gross amounts, and
21 Defendant shall have no liability for any such liens, interest, or bills.

22 IT IS FURTHER ORDERED That neither party shall recover against any other party their
23 respective fees, costs, nor interest herein except as stated above.

24 IT IS FURTHER ORDERED That the Defendant, State of Washington, shall pay to the
25 previously appointed Settlement Administrator, CPT Group, Inc., the sum of Eleven Million Five
